In 1994, Southwestern Law School purchased the landmark Bullocks Wilshire building from the R.H. Macy Company—an event that marked the beginning of a new era for the law school and the building. BECOME A PART OF HISTORY

Since its construction in 1929, the Bullocks Wilshire building has been a proud part of Los Angeles history. It was designated as Los Angeles Cultural Monument #56 in 1969, and has been listed on the National Register of Historic Places since 1978. In 1999, it was selected as a project of "Save America's Treasures," a public-private partnership between the National Trust for Historic Preservation and the White House Millennium Council. Today, the Bullocks Wilshire building is once again taking its place in the life of the Los Angeles community.
