INTRODUCING NEW FACULTY



DAVID FAGUNDES

David Fagundes' interest in the law grew out of his study of medieval legal history at Harvard College. As an undergraduate, he received the Philip Washburn Prize for best senior history thesis, the William Scott Ferguson Award for best sophomore essay, and the Department of History Award for best overall record as a history concentrator. He remained at Harvard for law school, where he served as an articles editor of the *Harvard Law Review*.

After law school, Professor Fagundes clerked for Judge David S. Tatel of the U.S. Court of Appeals for the D.C. Circuit, and then worked as an associate at Jenner & Block LLP for two years in Washington, D.C. His time in Washington included a leave from practice to be a Visiting Research Fellow at Georgetown University Law Center. In 2005, Professor Fagundes joined the University of Chicago Law School as a Bigelow Fellow and Lecturer in Law. During his two years there, he taught legal research and writing while developing his own scholarship, including "State Actors as First Amendment Speakers," an article recently published in the *Northwestern University Law Review*.

Professor Fagundes' research and teaching interests cover a variety of property law issues, including copyright, real property and land use. "The notion of property is ancient, but it has undergone profound changes in recent years," he said. "Examining different subject matter—real estate, chattels, copyrights, or patents—forces us to ask foundational questions about what property is, both as a social institution and a legal idea." His current research concerns the relationship between tangible and intangible property, and in particular whether rules governing physical property can provide a template for thinking about intellectual property as well.

Professor Fagundes was appointed to the Southwestern faculty commencing Fall 2007. Originally from the East San Gabriel Valley, he is glad to return to Southern California and looks forward to being in Los Angeles – and at Southwestern in particular – where the profession and legal education are "on the cutting edge of developments in intellectual property and entertainment law."

While she was a law student, Janine Kim was able to pursue her interest in both human rights and corporate law as executive editor of the *Yale Human Rights and Development Law Journal* and as a member of the Lowenstein Human Rights Project that dealt with Shell Oil's conduct in Nigeria.

When she first entered the legal profession in 1999, Professor Kim practiced in the area of corporate law, drafting contracts in connection with domestic and international loan transactions and securities offerings as an associate in the firm of Simpson, Thacher & Bartlett in New York. Three years later, she took an opportunity to serve as law clerk to Judge Alfred T. Goodwin of the U.S. Court of Appeals for the Ninth Circuit in Pasadena.

Professor Kim returned to academia in 2003 as an assistant professor of law at Whittier Law School, where she taught courses on criminal law and criminal procedure, served as an adviser to the Asian Pacific American Law Students' Association, and organized the junior faculty discussion series on scholarship, teaching and other issues of interest to tenure-track and visiting professors. She was appointed to the Southwestern faculty commencing in Fall 2006.

Professor Kim devotes time to research and writing in the areas of criminal law and race and the law. "I've been writing about topics such as hate crime law and unorthodox criminal defenses like the cultural defense to examine how these issues challenge our assumptions about what the law is and what it ought to be," she said.

Active in the community, Professor Kim has been a member of the board of the Korean American Coalition (Orange County) and the Community Outreach Committee of the Orange County Asian American Bar Association.

As an undergraduate at Yale, Gowri Ramachandran demonstrated that her interest and intellect cover a wide spectrum when she received the John Meeker Prize for creative writing and the Anthony D. Stanley Prize for excellence in pure and applied mathematics. She went on to garner recognition for her pedagogical skills as well, as a teaching fellow at Harvard where she was awarded the Derek Bok Prize for excellence in teaching, based on student evaluations, and her eventual career path was set.

“My main goal is to make students excited and comfortable speaking about the law,” Professor Ramachandran said. “I think a lot of students come to law school idealistic and lose that idealism along the way. My goal is to keep them from losing it.”

As a law student, she cultivated her diverse interests serving as editor-in-chief of the *Yale Law Journal* and as a board member of the Collective of Women of Color. She also received an Olin Fellowship for Law, Economics and Public Policy Research. After graduating in 2003, she served as law clerk to Judge Sidney R. Thomas of the U.S. Court of Appeals for the Ninth Circuit in Montana.

A year later, Professor Ramachandran returned to the classroom as a Future Law Professor Fellow at Georgetown University Law Center and taught feminist legal theory as a member of the adjunct faculty there. This past spring, she was a visiting professor at Florida State University Law School, teaching federal jurisdiction and a survey course in anti-discrimination law. She was appointed to the Southwestern faculty commencing Fall 2006 and teaches Constitutional Law, as well as Employment Law Transactions in the SCALE program.

Professor Ramachandran’s research focuses on employment discrimination and employment law, federal courts, constitutional law, and queer theory. Through her current scholarship, she has been challenging conventional notions of image and identity and the laws that shape those concepts, particularly within institutions where personal freedoms are often thought irreconcilable with wider social good, such as workplaces, schools, and prisons. Her article exploring these issues, “Freedom of Dress: State and Private Regulation of Clothing, Hair, Makeup, Tattoo and Piercing Choices,” was recently published in the *Maryland Law Review*. “We’re working longer and longer hours, and I think of the workplace as more of a public space. That’s why I’m interested in personal freedoms and equality in the workplace,” she said.

Julie Waterstone discovered her passion for child advocacy as a law student working with children in the delinquency system through the Children and Family Justice Center of Northwestern's Bluhm Legal Clinic. "I had heard the clinic was a good experience — and I was looking for something different — but I never expected it to speak to me so loudly," she said. Through her clinical experience, she participated in community outreach efforts and also served as a student instructor in the Street Law program.

After graduation, Professor Waterstone returned to her native Southern California and spent the next three years working as a civil litigator at Milbank, Tweed, Hadley & McCloy in Los Angeles to hone her litigation skills. But it was her pro bono work during that time that brought her the most satisfaction.

With a desire to pursue public interest law full time, Professor Waterstone accepted a position with the Civil Legal Clinic at the University of Mississippi School of Law. There, as a clinical professor, she created and developed the Child Advocacy Clinic, supervised students and taught the accompanying clinic seminar.

Three years later, she once again returned to Los Angeles where she joined Public Counsel as a staff attorney, litigating special education cases and training lawyers and law students as pro bono special education advocates.

Beginning in Fall 2007, Professor Waterstone will have the opportunity to apply her skills and knowledge while directing and teaching in Southwestern's new Children's Rights Clinic. She will help create and develop a program that she hopes "will ignite in students the same fire for public interest law and pro bono work" that prompted her to get into the field. She will work with approximately eight students each semester on a variety of legal issues that best suit the needs of the community's youth and at the same time provide valuable experiences for the law students. One of her goals is to create a holistic child advocacy clinic that addresses education, dependency, and delinquency issues faced by youth in Los Angeles.

Professor Waterstone also maintains an active role in the community and has served on a number of boards, including the Executive Board of the Mississippi chapter of the American Civil Liberties Union, the Advisory Board of the Southern Juvenile Defender Center, and the Legal Advisory Committee of the Anti-Defamation League of Los Angeles.

Alexandra D'Italia aims to help law students look at writing in a whole new way and stresses that form is just as important as content. "You lose the opportunity to make an argument by not writing well. On a close case, the writing and analysis does make the difference," she said. Professor D'Italia knows this from experience, having practiced law in San Francisco for several years, primarily representing indigent defendants on appeal as a panel attorney for the Sixth District Appellate Program.

She began teaching law in 2002 as a member of the adjunct faculty at Golden Gate University School of Law where she taught courses in the first-year legal writing program and the academic support program, developed a new advanced legal writing elective, and served as a faculty advisor to the law review. Professor D'Italia then served as an assistant professor of Lawyering Skills at Western State University College of Law where she taught Professional Skills I and II in the first-year required legal research and writing program. She was appointed to Southwestern's faculty in 2006.

Professor D'Italia has also served as a contributing author and editor of treatises on Criminal Law Advocacy, Texas Tort and Remedies, Texas Litigation Guide, Illinois Tort Law, Illinois Civil Trial Guide, and Business Insurance Law for Matthew Bender & Company. In law school, she was managing editor of the law review and a Public Interest Law Scholar.

As a Southwestern alumna and legal writing instructor, Catherine Kunkel Watson has been where her students sit. She knows that to learn legal writing isn't just a matter of absorbing a new language, but also a different way of contemplating. "Once you get out of law school, your thinking pattern is different. You don't think the same way that the everyday person does," she said.

Before serving on the faculty at Southwestern, Professor Watson combined her lifelong interest in medicine with law through a career in malpractice defense. She joined the firm of Rushfeldt, Shelley & Drake where she handled medical malpractice cases, specializing in staff privilege defense and government entity defense.

Professor Watson initially joined the law school's adjunct faculty in 1990, and a year later was appointed as a full-time instructor of legal writing, also serving as a faculty advisor to the Moot Court Honors Program. She returned to Southwestern in the fall of 2006 after retiring in 2002 to attend to family matters. When she was a student at Southwestern, Professor Watson served on Law Review and received an award for excellence in legal writing.

As an instructor, she says that the process of teaching legal writing is thrilling, especially when it really starts to click. "I like watching the students learn. I like watching their face light up when they find out how simple this all really is," she said.
