#### Calculating Graduation Rates:

Graduation rates measure how many students graduate within 150% of their program's normal completion time. This period is set at the time the student is established in their First-Year Class (FYC) cohort using the program the student is enrolled in at that time.

#### 150% of Normal Completion Time:

- **Accelerated Program (SCALE):** 3 years
- **Full-Time Programs:** 4.5 years
- **Part-Time Programs:** 6 years

## **Understanding Graduation Rates at Southwestern Law School**

### **What is a First-Year Class (FYC) Cohort?**

An FYC cohort is a group of students who enter as first-year Juris Doctor students in a specific academic year. The Council on Legal Education and Admissions to the Bar of the American Bar Association (ABA) approves protocols each year for defining and reporting the FYC in the ABA's Annual Questionnaire. The FYC is typically defined as those students who enrolled as first-year students and were enrolled as of the official school census date of October 5.

Once a student is established in a FYC cohort, they remain in the cohort, even if they change programs, withdrawal, or transfer out of the institution. Students may be excluded from a FYC cohort only for the following reasons: (i) have left school to serve in the Armed Forces; (ii) have left school to serve on official church missions; (iii) are totally and permanently disabled; or (iv) are deceased.

### **Different Programs and Graduation Times:**

Southwestern offers various pathways to earn a J.D. degree, and the normal time to complete the degree requirements for each pathway differ:

- **Accelerated Program (SCALE):** 2 years
- **Full-Time Programs:** 3 years
- **Part-Time Programs:** 4 years

### **Example:**

The 2023 FYC cohort consists of first-year J.D. students beginning their study of law in academic year 2023-2024 and who are enrolled in classes on October 5, 2023.

- Accelerated students in this cohort are expected to graduate in 2024.
- Full-time students in this cohort are expected to graduate in 2025.
- Part-time students in this cohort are expected to graduate in 2026.
