In 2006, argued the Direct Appeal before the Texas Court of Criminal Appeals, and prepared the central portions of the Direct Appeal, Reply and Supplemental Briefs. In 2007, filed a Motion for Rehearing, and filed a Brief for the Government of the Argentine Republic as *Amicus Curiae* in Support of Petitioner before the U.S. Supreme Court. Assisted local counsel in the Federal habeas corpus proceedings and presented the *Amicus Curiae* Brief of the Government of the Argentine

Saldaño, Víctor v. Government of the United States of America, Case No. 12.254, Inter-American Commission on Human Rights, Merits Report No. 24/17, presently in enforcement/follow-up stage — Representing an Argentine on death row in Texas before the Inter-American Commission on Human Rights, arguing that illegal ethnic profiling and subsequent mental decline on Death Row when a prosecution expert testified that the defendant constituted a future danger to society because as a Latino he belonged to a group that committed more crime than the general population. The U.S. Department of State supported Saldaño by writing a letter in 2010 to the U.S. District Court for the Eastern District of Texas emphasizing the need for an evidentiary hearing on Saldaño's mental decline. (From 2014 - 2020 participation in the case before the Commission was limited and was at the behest of Scott Smith, federal habeas counsel.)

Birt, Guillermo Alberto c/Estado Nacional Argentino, Case No. 10.310, Inter-American Commission on Human Rights, 1989-1992 — Under the auspices of the Washington Office on Latin America, representing victims of human rights violations by the Argentine military government of 1976 - 1983, before the Inter-American Commission of Human Rights. The actions concluded with the first friendly settlement in the history of the Commission and substantial compensation for the victims and their survivors.

Siderman v. Republic of Argentina, U.S. District Court for the Central District of California, 1996 — Presented an extensive expert opinion on Argentine tort law and on the state of the Argentine judiciary during and after the military government of 1976-1983 in an action brought against the Argentine government for human rights violations committed during the military government. The case concluded with a settlement.
